8 · PAYMENT TERMS

- ▶ OverhaulOS invoices your company once per month for all completed recovery jobs.
- ▶ Your company loads credit in advance by EFT; every approved job draws the balance down.
- ▶ A platform fee (currently 5%) is included in each job line. No cash is ever paid at the roadside.
- ▶ On acceptance a job's estimate is held against your balance; the real invoice replaces it at completion. If the balance cannot cover a job, new jobs pause until you top up. Disputes must be raised within 30 days.
- ▶ Late payment may attract interest at the maximum lawful rate and suspension of coverage.
